2027 JONES COUNTY FIVE YEAR ROAD CONSTRUCTION PROGRAM

Each year the Board of Supervisors, with the assistance of the County Engineer, shall adopt a Secondary Road Construction Program. The program shall include a project accomplishment list for the next fiscal year and a project priority list for the succeeding four fiscal years based upon the construction funds estimated to be available for the period. The Board's primary investment objectives remain stewardship (i.e. safety, maintenance and modernization) of Jones County's existing roadway system.

The Jones County Board of Supervisors hereby set a Public Hearing for the 2026 Jones County Five Year Road Construction Program. The Public Hearing will be held at 9:00 A.M. on December 23, 2025, in the Board Room at the Jones County Courthouse, 500 W Main Street in Anamosa.
