PUBLIC MEASURES

Anamosa School Public Measure ME- Shall the Board of Directors of the Anamosa Community School District, in the Counties of Jones and Linn, State of Iowa, for the purpose of purchasing and improving grounds; constructing schoolhouses or buildings and opening roads to schoolhouses or buildings; purchasing of buildings; purchase, lease or lease-purchase of technology and equipment; paying debts contracted for the erection or construction of schoolhouses or buildings, not including interest on bonds; procuring or acquisition of libraries; repairing, remodeling, reconstructing, improving, or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; renting facilities under Iowa Code Chapter 28E; purchasing transportation equipment for transporting students; lease purchase option agreements for school buildings or equipment; purchasing equipment authorized by law; or for any purpose or purposes now or hereafter authorized by law, be authorized for a period of ten (10) years, to levy annually, a voter-approved physical plant and equipment property tax not to exceed Sixty Seven Cents (\$0.67) per One Thousand Dollars (\$1,000) of the assessed valuation of the taxable property within the school district commencing with the levy for collection in the fiscal year ending June 30, 2027, or each year thereafter?

North Cedar School Public Measure DS- Shall the Board of Directors of the North Cedar Community School District in the Counties of Cedar and Jones, State of Iowa, be authorized for a period of ten (10) years, to levy and impose a voter approved physical plant and equipment tax not to exceed sixty-seven (67 cents) per one thousand dollars (\$1000.00) of assessed valuation of the taxable property within the school district, and be authorized annually, in combination, as determined by to board, to levy a physical plant and equipment property tax upon all the taxable property within the school district commencing with the levy of property taxes for collection in the fiscal year beginning July 1, 2024, and to impose a physical plant and equipment Income surtax upon the state individual Income tax of each individual Income taxpayer resident in the school district on December 31 for each calendar year commencing with 2024 calendar year, or each year thereafter, (the percent of Income surtax not to exceed three percent to be determined by the board year), to be used for the purposes permitted by law?
