#### Compensation Board meeting attendance and participation provisions during this public health emergency:

The Compensation Board will meet in the basement conference room. The County is providing alternate opportunities detailed below for remote participation via the internet, and various telephone options.

Due to the COVID-19 public health emergency, and to abide by health safety and social distancing guidelines, the public will not be permitted to be physically present at the meeting, unless pre-approved for a specific agenda item. Remote participation options are available and further described elsewhere on this agenda. All persons who will be physically present at the meeting must go through a health screening survey at the secured west entrance to the Courthouse.

Remote participation is available via telephone and the internet using the information at the bottom, or second page, of this agenda. Various telephone numbers are listed in that information for audio only access.

The meeting will typically proceed in the order listed on the agenda, with the meeting adjourned when the business of the Board is concluded. Given the current public health emergency declared by the Governor, with respect to COVID-19, it is the position of the County that this meeting may occur electronically, as authorized under Iowa Code Section 21.8, as it is impossible or impractical to have the meeting in person and fully open to the public.

Iowa Code section 331.907 prescribes the process for adoption by the Board of Supervisors, including possible reductions to the recommendations. The compensation schedule adopted by the Board of Supervisors for the elected officials shall not exceed the recommendations of the Compensation Board.
