### Official Rules:

1. Photos must have been taken in Jones County.
2. Make sure to label each digital photo submitted with a title, your name, location of the photo, year taken, and the category the photo is being entered in.
3. Entries must be submitted by May 31, 2021.
4. In order to be displayed in our online gallery without being stretched or distorted, photographs must be submitted in .jpeg, .jpg or .gif format - at least 2,000 pixels wide and no larger than 10 MB.
5. Cropped photos are eligible. We do not accept digitally or otherwise enhanced or altered photos. Minor adjustments, including spotting, dodging and burning, sharpening, contrast and slight color adjustment or the digital equivalents, are acceptable. If the judges determine that a photographer has excessively altered his or her photo, we reserve the right to disqualify it.

## OFFICIAL ENTRY FORM

6. Members and employees of the Jones County Conservation Board, and their immediate families are not eligible for this contest.
  7. Individuals whose main source of income is photography are not eligible for this contest.
  8. **Each participant is limited to five entries.**
  9. The Jones County Conservation Board reserves the right to make any and all decisions regarding interpretation of these rules.
  10. Photographers retain ownership and all rights to photograph; however, by entering the contest, entrants grant the JCCB permission, royalty-free, to publish submitted photos on the Center's website, newsletter, local newspapers, and to reproduce images for outreach and promotional purposes. Any photograph reproduced will include a photographer credit as feasible. JCCB will not be required to pay any consideration or seek any additional approval in connection with such uses.
  11. Previous years winning entries are not eligible.
  12. Drone images may only be submitted under the Natural Jones County by Drone category.
  13. All people recognizable (showing their face) in photos need to fill out and submit a model release form with the entry. Model release forms can be downloaded at <https://www.jonescountyiowa.gov/conservation/>

\*Press releases will be mailed to local newspapers following judging and results will be posted on the JCCB website and Facebook page by the end of June 2021.
