Review of Nick Zirkelbach's Derecho Tree Trimming Work in Central Park: The Board tabled.

Derecho Windstorm Related County Insurance Claim and Additional Tree Trimming Bid
Review: Dave made a motion to approve up to $\$ 28,300$ of tree trimming at Central Park with the awarded company meeting the following insurance thresholds:
CONTRACTOR shall provide and maintain insurance throughout said Project in the following minimum amounts:

1. Workman's Compensation insurance in accordance with the laws of the State of Iowa covering all employees who perform any of the obligations under the Agreement
2. Public liability and property damage liability insurance covering all operations under the Agreement, limits for bodily injury or death not less than five hundred thousand dollars ( $\$ 500,000.00$ ) for one person and one million dollars $(\$ 1,000,000.00)$ for each accident; for property damage not less than five hundred thousand dollars ( $\$ 500,000.00$ ) for each accident and one million dollars $(\$ 1,000,000.00)$ aggregate during such policy period.

Review of the Austin Strong Foundation Freeze Out Cancer Ice Fishing Tournament at Central Park: Dave made a motion to approve Austin Strong Foundation Freeze Out Cancer Ice Fishing Tournament on Central Park Lake. Seconded by Jeff. All ayes. Motion carried.

Review of the Wapsipinicon Trail Phase II Engineering Plan and Easement Acquisition:
Dean made a motion to approve the Preliminary Wapsipinicon Trail Phase II Engineering Plan and to approve an agreement with the landowner for a permanent easement that allows the design to move forward. Seconded by Dave. All ayes. Motion carried.
