Due to the COVID-19 public health emergency, and to abide by health safety and social distancing guidelines, the public will not be permitted to be physically present at the meeting, unless pre-approved for a specific agenda item. All county staff and pre-approved visitors who will be physically present at the meeting must go through a health screening survey at the secured west entrance to the Courthouse.
