

Jones County Solid Waste Commission Meeting Minutes

July 5th, 2022

The Jones County Solid Waste Commission meeting was held at the Jones County Transfer Station. Those present were Chairman Russ Benke, Ned Rohwedder (Jones County Board of Supervisors), Dale Barnes (Anamosa), Dave Dircks (Olin), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Dale Barnes to approve the minutes from the June meeting. The motion was seconded by Dave Dircks and was approved with all voting Aye.

The expenditures and financial reports were reviewed, and a motion was made by Dale Barnes to approve the bills for payment. The motion was seconded by Ned Rohwedder and passed with all voting Aye.

Alicia Presto from ECICOG updated the board on the progress of the summer reading program as well as the Comprehensive Planning process. Members were invited to attend the quarterly TAC meeting including a tour of Midwest Electronics Recovery.

Old Business:

The board re-visited current trash disposal cost as affected by rises in hauling costs due to fuel prices. The issue was tabled until the August meeting to see what prices do.

New Business:

The board discussed the prospect of extending current contract vs. the RFP process. A motion was made by Dale Barnes to see if current vendor is willing to extend at current rates. If not, the commission will issue a request for Proposals. Ned Rohwedder seconded the motion and it passed with all voting Aye.

A proposal was made to have an Appreciation Day for our regular customers at a date to be determined. Hamburgers and hot dogs on the grill. Ned Rohwedder moved to approve the idea with a second from Dale Barnes. The motion passed with all voting Aye.

The board reviewed current tire disposal pricing after price increases in the new contract beginning July 1, 2022. A motion was made by Dale Barnes to increase the charge for tire disposal to \$.20 per pound effective August 1st, 2022. Dave Dircks seconded the motion and it passed with all Ayes.

Karl Taylor updated the board on the use of concrete from a county road project to fill in a low spot on the transfer station grounds.

Dale Barnes moved to adjourn the meeting and it was adjourned at 5:45 p.m.
