

Jones County Solid Waste Commission Meeting Minutes

September 6th, 2022

The Jones County Solid Waste Commission meeting was held at the Jones County Transfer Station. Those present were Chairman Russ Benke, Ned Rohwedder (Jones County Board of Supervisors), Jeff Swisher (Jones County Board of Supervisors), Dale Barnes (Anamosa), Dave Dircks (Olin), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

Visitors

Fred Kissack and Dominic Remmes from Millenium Waste Quad Cities Landfill attended to answer any questions the board had regarding the proposed 2022 Trash Disposal contract.

Clark Hagen from VIP Sanitation was in attendance for the opening of bids for the Trash Hauling contract RFP that closed on September 2nd.

A motion was made by Jeff Swisher to approve the minutes from the previous month's meeting. Dale Barnes seconded the motion and it passed with all voting aye.

The expenditures and financial reports were reviewed with Dale Barnes making a motion to approve them. Jeff Swisher seconded and it passed with all voting aye.

ECICOG

Alicia Presto updated the board on the summer reading program which is finished for the year. She also talked about the progress with the survey portion of the comprehensive plan as well as likely next steps.

New Business:

A motion was made by Jeff Swisher with a second from Dale Barnes to approve the proposed contract from Millenium Quad Cities Landfill for disposal of trash. The motion was approved with all voting aye.

The bids for hauling were opened. Two bidders submitted proposals. VIP Sanitation and Midwest Injection incorporated. A motion was made by Ned Rohwedder with a second from Dale Barnes to vote on the issue in a special meeting to take place via zoom on September 14th. The timing is to allow the Commission to address any specific questions with either of the bidders.

A motion was made by Dale Barnes to enter into the record that Jake Gravel was no longer employed by the SWMC with a resignation effective date of August 1, 2021. Jeff Swisher seconded and it passed with all ayes.

There was a brief discussion about sick leave for part time workers. Karl Taylor was tasked with discussing the policy with the Auditor's office.

Dale Barnes moved to adjourn the meeting and it was adjourned at 6:05 p.m.
