Jones County Solid Waste Commission Meeting Minutes

May 2nd, 2023

The Jones County Solid Waste Commission meeting was held at the Jones County Courthouse. Those present were Chairman Russ Benke, Jeff Swisher (Jones County Board of Supervisors), William Roller (Morley), Dave Dircks (Olin), Wayne Peach (Monticello), Dave Goedken (Monticello), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Swisher to approve the minutes from the previous month's meeting. Dircks seconded the motion and it passed with all voting Aye.

The expenditures and financial reports were reviewed with Goedken making a motion to approve them. Roller seconded the motion and it passed with all voting aye.

ECICOG:

Alicia Presto reported that the Comprehensive Solid Waste plan had been approved by DNR. She updated the status of the Summer Reding Program with Anamosa, Monticello and Olin libraries already scheduled.

Old Business: There was no old business.

New Business:

A. The board discussed the creation of a Transfer Station written safety plan at the suggestion of IMWCA. Presto agreed to help with the process with input from Staci from IMWCA. Taylor was advised to reach out to the Chairman of the Safety Board for input.

B. Taylor proposed setting a minimum monthly average usage level for charge customers to minimize the time and expense of generating and processing small dollar invoices. The issue was tabled until the July meeting to allow Taylor provide data on monthly account usage.

C. There was a discussion about the prospect of filling in a small portion of the low spot between the Transfer Station and the old Scale House with fill material from upcoming road projects. Taylor was advised to contact the Engineer's office regarding future fill materials.

Peach moved to adjourn, and the meeting was adjourned at 5:40 p.m.
