The Jones County Board of Supervisors met in regular session. Present Supervisors Swisher, Oswald, Rohwedder, Schlarman, and Zirkelbach.

Moved by Rohwedder seconded by Zirkelbach to approve the minutes of the May 9, 2023 meeting. All aye. Motion carried.

Moved by Oswald seconded by Schlarman to approve payroll for the period ending May 7, 2023. All aye. Motion carried.

The 911 Address Coordinator met with the Board to discuss changing the names of two roads located within the Timberwood Acres Pt 1 and Pt 3 subdivisions.

Moved by Oswald seconded by Zirkelbach to rescind the two road name change resolutions adopted on April 25, 2023 with reason being to clarify some language in the resolutions. On roll call vote: Schlarman aye, Zirkelbach aye, Rohwedder aye, Oswald aye, Swisher aye. Motion carried.

#### RESOLUTION FOR ESTABLISHING SPEED LIMITS

WHEREAS, the Board of Supervisors is empowered under authority of the Iowa Code Sections 321.255 and 321.285 of the Code of Iowa, to determine upon the basis of an engineering and traffic investigation, that the speed limit of any secondary road is greater than is reasonable and proper under the conditions existing, and may determine and declare a reasonable and proper speed limit, and

WHEREAS, such an investigation has been requested and has been completed by the Iowa Department of Transportation, and

WHEREAS, the Board of Supervisors has determined that the speed is greater than is reasonable and proper due to increased pedestrian activity and development along the roadside.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF JONES COUNTY that the speed limit be reduced and appropriate signs be erected at the location described as follows:

On 190TH STREET, fifty-five (55) miles per hour (mph) from IA 38, eastward, to a point 1300 feet east of 130TH AVENUE. At this point, thirty-five (35) mph, eastward, to a point 550 feet east of 122ND AVENUE. At this point a twenty-five (25) mph commences to the end of 190TH STREET. [2023-075]

During the public comment period, Brad Hatcher with the Stone City Foundation met with the Board to inquire about a letter of support for a grant that would help with the remodel of the old ice wagon building. The Sheriff also met with the Board about an upcoming meeting with Shive Hattery to review potential sites for a future public safety building.

The Board gave brief updates on past and future committee meetings.
