JONES COUNTY IOWA ORDINANCE 2023-03

An ordinance amending the code of ordinances of the County of Jones, State of Iowa.

Be it enacted by the Board of Supervisors of Jones County, Iowa as follows:

<u>Section 1:</u> The purpose of this ordinance is to amend CHAPTER 3, JONES COUNTY ZONING ORDINANCE OF TITLE VI – PROPERTY & LAND USE by amending the zoning map.

<u>Section 2:</u> The Chapter will be amended as follows:

Amend SECTION 5. <u>BOUNDARIES AND OFFICIAL ZONING MAP</u>, of ARTICLE IV – GENERAL REGULATIONS AND PROVISIONS by amending, subject to the terms of a contractual development agreement, the zoning of property briefly described as Parcel 2011-01, Parcel 95-72, and part of a parcel defined as the SW ¼ SW ¼ Section 11, Township 86, North, Range 3, West of the 5th P.M., (tax parcels 02-11-351-009, 02-11-351-015, and 02-11-351-018) containing approximately 23.37 acres, from the A-Agricultural Zoning District to the R-Residential Zoning District.
