Moved by Rohwedder seconded by Oswald to approve, and place on file, the Auditor's Report of Fees Collected for the quarter ending September 30, 2023. All aye. Motion carried. [2023-147]

Moved by Zirkelbach seconded by Schlarmann to approve the extension of the COAP Grant through September 30, 2024. All aye. Motion carried. [2023-148]

Moved by Zirkelbach seconded by Rohwedder to open the public hearing at 9:15 a.m. on a proposal to rezone part of the NW ¼ SE ¼ containing 5.53 acres located in Section 36 of Cass Township, located near 13504 Highway 151, Anamosa, from the R-Residential District to the C1-Commercial District. JONES COUNTY IOWA ORDINANCE 2023-04

An ordinance amending the code of ordinances of the County of Jones, State of Iowa.

Be it enacted by the Board of Supervisors of Jones County, Iowa as follows:

<u>Section 1:</u> The purpose of this ordinance is to amend CHAPTER 3, JONES COUNTY ZONING ORDINANCE OF TITLE VI – PROPERTY & LAND USE by amending the zoning map.

Section 2: The Chapter will be amended as follows:

Amend SECTION 5. <u>BOUNDARIES AND OFFICIAL ZONING MAP</u>, of ARTICLE IV – GENERAL REGULATIONS AND PROVISIONS by amending, subject to the terms of a contractual development agreement, the zoning of property described as a parcel of land located in the NW ¹/₄ SE ¹/₄ of Section 36, Township 85 North, Range 4 West described as follows: Beginning at the Center of said Section 36-T85N-R4W; thence N88°58'15"E along the North line of said NW ¹/₄ SE ¹/₄ a distance of 343.30 feet to the Point of Beginning, said point also being a corner on the Southeasterly Right-of-Way of U.S. 151; thence N88°58'15"E continuing along said North line of said NW ¹/₄ SE ¹/₄ a distance of 321.15 feet to a point on said North line; thence S01°04'11"E a distance of 205.81 feet; thence S46°42' 48"W a distance of 508.06 feet; thence N69°28' 43"W a distance of 309.39 feet to a point on the West line of said NW ¹/₄ SE ¹/₄; thence N01°06'40"W along said West line a distance of 115.36 feet to a corner on said Southeasterly Right-of-Way of said U.S. 151; thence N35°58'17"E along said Southeasterly Right-of-Way ine a distance of 303.32 feet to a corner of said Right-of-Way; thence N63°32'32"E along said Southeasterly Right-of-Way line a distance of 177.29 feet to the Point of Beginning; said parcel contains 5.53 Acres, more or less, from the R-Residential District to the C1-Commercial District.

Section 3. When Effective

This ordinance shall be in full force and effect from and after its final passage, approval, and publication as provided by law.
