Motion by Stamp seconded by Teidt to open the public hearing at 5:30 p.m. to rezone part of the NW ¼ SE ¼ containing 5.53 acres located in Section 36 of Cass Township, located near 13504 Highway 151, Anamosa, from the R-Residential District to the C1-Commercial District. The reason for the request is to allow for construction of a winery and event center. All aye. Motion carried.

The application, aerial map, and written report were sent to the Commission and regular and certified letters were sent to adjacent landowners. At the time of the meeting, four of the nine adjacent landowners had not received their certified letters. There were no written or verbal comments received on the application. The owner and applicant both received a copy of the written report. The applicants, Dan and Judy Lubben, explained their business plan for the property including a vineyard, event center, winery, tasting room, and living quarters. This property does have the correct soil type for grape production and allows for the type of atmosphere they are trying to achieve by being able to have the tasting room overlook country landscape. Sulzner asked about the safety of traffic turning on and off the

four-lane highway. Zeets commented that they are working with the Iowa DOT on a traffic study and will most likely have to put in turn lanes on both sets of lanes. Others present voiced that they are in full support of this business and think it would be a great addition to Jones County. Fay did ask that if all is approved that they do follow lighting requirements per the Jones County Zoning Ordinance by placing shields over all outdoor lighting.

Motion by Tiedt seconded by Sulzner to close the public hearing at 5:48 p.m. All aye. Motion carried.
