

Jones County Solid Waste Commission Meeting Minutes

December 5th, 2023

The Jones County Solid Waste Commission meeting was held at the Jones County Courthouse. Those present were Chairman Russ Benke, Ned Rohwedder (Jones Co. Supervisor), Jeff Swisher (Jones Co. Supervisor), Dale Barnes (Anamosa), Dave Dircks (Olin), Wayne Peach (Monticello), Will Roller (Morley), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Rohwedder to approve the minutes from the previous month's meeting. Barnes seconded the motion and it passed with all voting aye.

The expenditures and financial reports were reviewed with Swisher making a motion to approve them. Roller seconded the motion and it passed with all voting aye.

ECICOG: Alicia Presto updated the board on the ongoing planning for future community programs including the Summer Reading Program. The board reviewed draft copies of signage and press releases regarding the Glass Recycling Program which will go live in the very near future.

New Business:

A. The board discussed the status of replacing tarps on the transfer trailers and other ways to mitigate litter from vehicles coming to and from the transfer station.

B. The board briefly discussed holiday bonuses for transfer station staff. A motion was made by Barnes to give each JCSWMC employee a \$125 bonus. Rohwedder seconded the motion and it passed with all ayes.

C. The board discussed whether to join with Jones County in getting outside bids for our annual audit. Barnes moved to approve seeking bids jointly with Jones County. Peach seconded the motion and it passed with all voting aye.

Barnes moved to adjourn, and the meeting was adjourned at 5:30 p.m.
