## P25 Possible Turn on for County EMS and Fire

Schwab reported that Martelle does now have all of its radios and is ready with a couple weeks of training to go to P25. After discussion among board members January 3<sup>rd</sup> was selected as the P25 switchover for Fire and EMS in Jones County. Schwab will send an email Monday morning December 11<sup>th</sup> notifying all departments of the switchover date. A reminder and text alerts will be issued on Tuesday January 2<sup>rd</sup> 2024 of the switch on the 3rd

## **Other Items of Interest**

Schwab reported that work on the FY 25 budget recommendation has started and will be on the January agenda. The dispatch phone system refresh will be in this budget and is slated to happen approximately in May of 2025. A request has been logged with Zetron for an estimate of the cost. Another expense that will be budgeted is a refresh of the UPS systems on Temple Hill and Wyoming tower sites.
