

## Jones County Solid Waste Commission Meeting Minutes

March 5th, 2024

The Jones County Solid Waste Commission meeting was held at the Jones County Courthouse. Those present were Chairman Russ Benke, Ned Rohwedder (Jones Co. Supervisor), Jeff Swisher (Jones Co. Supervisor), Dave Goedken (Monticello), Dave Dircks (Olin), Will Roller (Morley), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Rohwedder to approve the minutes from the previous month's meeting. Swisher seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Swisher making a motion to approve them. Dirks seconded the motion and it passed with all voting ayes.

ECICOG: Alicia Presto updated the board on the status of the RFP for white goods and the Summer reading program.

## **New Business:**

**A.** The subject of hiring Thad Campbell as a part time Operator was discussed. Goedken moved to approve his hiring at \$18.00 oer hour with a raise to \$19.00 after a 90 day probationary period. The motion was seconded by Rohwedder and was passed with all voting aye.

**B.** A proposal was made to increase David Haugsted to a rate of \$19.00 per hour from \$17.15 as an on call Operator. A motion was made by Goedken to approve. Rohwedder seconded the motion and it passed with all voting aye.

**C.** After a brief discussion about the time frame for purchasing a new end loader, the subject was tabled until the April meeting to get more info about current costs and production times.

Swisher moved to adjourn, and the meeting was adjourned at 5:30 p.m.
