The Jones County Solid Waste Commission meeting was held at the Jones County Transfer Station. Those present were Chairman Russ Benke, Ned Rohwedder (Board of Supervisors), Jeff Swisher (Board of Supervisors), Will Roller (Morley), Dave Goedken (Monticello), Dave Dircks (Olin), and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Rohwedder to approve the minutes from the previous month's meeting. Swisher seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Goedken making a motion to approve them. Rohwedder seconded the motion and it passed with all voting ayes.
