



## Jones County Solid Waste Commission Meeting Minutes

January 7<sup>th</sup>, 2025

The Jones County Solid Waste Commission meeting was held at the Jones County Transfer Station. Those present were Russ Benke (Chairman), Jeff Swisher (Board of Supervisors), John Schlarmann (Board of Supervisors), Dave Goedken (Monticello), Dave Dircks (Olin), Will Roller (Morley), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Goedken to approve the minutes from the previous month's meeting. Dircks seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Goedken making a motion to approve them. Roller seconded the motion and it passed with all voting ayes.

- A.** A motion was made by Swisher to keep the same officers for another year and nominated John Schlarmann to replace Ned Rohwedder as Vice Chairman. Goedken seconded the motion, and it was adopted with all voting aye.
- B.** After a brief review of revenues vs. expenses a motion was made by Goedken to increase tipping fees for trash to \$70.00/ton and commercial recycling to \$95.00/ ton effective July 1<sup>st</sup>, 2025. Swisher seconded the motion, and it passed with all voting Aye.
- C.** Taylor informed the board that no further inactive charge accounts be deleted.
- D.** The subject of Holiday bonuses as it wasn't on the agenda for the December 2024 meeting through an oversight. Swisher moved that the transfer station staff receive a bonus of \$125.00 each. Roller seconded the motion, and it passed with all voting Aye.
- E.** Taylor and Benke updated the board on the progress in restoring the Leachate Containment System to original design specs as well as the takeaways from a meeting with the DNR rep Taylor and Benke had previously in the day.
- F.** A motion was made by Swisher to approve renewing the annual contract with HLW for engineering services. Roller seconded the motion, and it passed with all Aye's.

Swisher made a motion to adjourn. Roller seconded and the meeting was adjourned at 6:20 P.M.
