The Jones County Solid Waste Commission meeting was held at the Jones County Transfer Station. Those present were Russ Benke (Chairman), Jeff Swisher (Board of Supervisors), John Schlarmann (Board of Supervisors) and Karl Taylor (Director JCSWC). Dan Van Fossen (Morley) and Alicia Presto (ECICOG) attended via Zoom.

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Swisher to approve the minutes from the previous month's meeting. Schlarmann seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Swisher making a motion to approve them. Schlarmann seconded the motion and it passed with all voting ayes.

Alicia Presto from ECICOG updated the board on plans for upcoming programs including Environmental Assembly and Summer Reading programs.
