

## Jones County Solid Waste Commission Meeting Minutes April 8th, 2025

The Jones County Solid Waste Commission meeting was held at the Jones County Transfer Station. Those present were Russ Benke (Chairman), Jeff Swisher (Board of Supervisors), John Schlarmann (Board of Supervisors) Dave Goedken (Monticello), Alicia Presto (ECICOG), Homer Schueller (Midwest Injection Inc.), Wendy Lyons (Midwest Injection inc.), Jason Andrews and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

Jason Andrews spoke to the board members about appliance recycling.

A motion was made by Swisher to approve the minutes from the previous month's meeting. Goedken seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Swisher making a motion to approve them. Goedken seconded the motion and it passed with all voting ayes.

Alicia Presto from ECICOG updated the board on plans for upcoming programs including Environmental Assembly and Summer Reading programs.

- **A.** Homer Schueller from Midwest Injection Inc. informed the board about repairs made to the transfer trailers and proposed a surcharge to apply when an extra driver runs. The issue of the extra driver charge was tabled until the May meeting to allow Presto to check into the contractual language involved.
- **B.** Taylor updated the board on the status of the alarm system for the leachate pumping system and the expected completion date.
- **C.** After a short discussion about whether to issue a RFP for hauling recycling, it was decided to table the issue until the May meeting to look into options.
- **D.** The members discussed options for removing the old scale house building. Taylor was tasked with putting an ad in the local papers offering it for sale or salvage.
- **E.** Swisher made a motion to approve hiring a part time operator for the transfer station. Schlarmann seconded the motion and it passed with all ayes.
- **F.** After reviewing the estimate for fixing the damaged pit door, Taylor was asked to look into submitting an insurance claim for the repairs.

Swisher made a motion to adjourn, and the meeting was adjourned at 6:35 P.M.
