

## Jones County Solid Waste Commission Meeting Minutes May 6th, 2025

The Jones County Solid Waste Commission meeting was held at the Jones County Transfer Station. Those present were Russ Benke (Chairman), Jeff Swisher (Board of Supervisors), John Schlarmann (Board of Supervisors) Dave Goedken (Monticello), Dan Van Fossen (Morley), Quinn Phelan (Monticello) Alicia Presto (ECICOG), Amber Sauser (Iowa DNR) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Swisher to approve the minutes from the previous month's meeting. Goedken seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Schlarmann making a motion to approve them. Goedken seconded the motion and it passed with all voting ayes.

Alicia Presto from ECICOG updated the board on plans for upcoming programs including Environmental Assembly and Summer Reading programs.

- **A.** Amber Sauser from DNR talked with the board about the standards and expectations for the day to day state of the transfer station and closed landfill.
- **B.** There was one bid submitted for the removal of the old scale house. John Schlarmann submitted a bis of \$800. A motion was made by Goedken and seconded by Phelan to accept the bid. The motion passed with all voting aye with the exception of Schlarmann and Swisher who abstained.
- **C.** The board reviewed the amended language to the agreement with Midwest Injection Inc. as it pertains to extra loads hauled by secondary driver. Swisher moved to accept the language as submitted. Goedken seconded the motion and it passed with all ayes.
- D. The issue of exploring options regarding recycling hauling was tabled until the June meeting.
- **E.** A brief discussion was held regarding the fire at Jackson County transfer station and what, if any, that would have on Jones County transfer station. No action was suggested.

Swisher made a motion to adjourn and the meeting was adjourned at 6:10
