

## Jones County Solid Waste Commission Meeting Minutes

The Jones County Solid Waste Commission meeting was held at the Jones County Transfer Station. Those present were Russ Benke (Chairman), Jeff Swisher (Board of Supervisors), John Schlarmann (Board of Supervisors) Dave Goedken (Monticello), Quinn Phelan (Monticello), Dave Dircks (Olin), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Goedken to approve the minutes from the previous month's meeting. Schlarmann seconded the motion, and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Goedken making a motion to approve them. Dircks seconded the motion, and it passed with all voting ayes.

Alicia Presto from ECICOG updated the board on plans for upcoming programs including Environmental Assembly and Summer Reading programs.
