Revised Resolution and Final Order of Road Vacation

Whereas a public hearing was held on July 29, 2025 for a proposal to vacate and close a road segment on the Jones County Secondary Road System described as follows:

That portion of undeveloped Fourth Street in the unincorporated town of Center Junction, bounded on the South by the Northerly line of Lot 1 and also the Northerly line of an undeveloped designated alley all in Block 49, said alley being twenty feet in width. Bounded North by the Southerly line of Lot 5 and also the Southerly line of an undeveloped designated alley all in Block 46, said alley being twenty feet in width. Bounded on the West by the East line of Lot 10 in Block 46 extended South to the South line of undeveloped Fourth Street. Bounded on the East by the Westerly line of Saint Paul Street, said street being sixty feet in width, all in the Original Town of Center Junction, Jones County, Iowa.

Also, that portion of an undeveloped designated North/South alley in the unincorporated town of Center Junction, said alley being 20.0 feet in width and lying within Block 46 of said unincorporated town of Center Junction, adjacent to Lots 1 through 5 to the East and Lots 6 through 10 to the West. Said Alley also lying adjacent to undeveloped Third Street to the West and Vacated Third Street to the East as recorded in the Office of the Jones County Recorder Instrument #2023-1647. Said Alley also lying within Block 43 of said unincorporated town of Center Junction, adjacent to Lot 5 to the East and Lot 6 to the West.

The above-described vacation is subject to easements and restrictions of record and contains 0.43 acres more or less.

Whereas, the previous resolution passed on July 29, 2025 described had an error in the legal description;

Whereas, all utilities presently located within the rights of way of the road being vacated shall retain their right to continue in possession of a rights of way in use at the time of the road vacation; and

Resolved by the Jones County Board of Supervisors that in accordance with Code of Iowa, Chapter 306, the subject segment of road is ordered vacated and closed and replaces the July 29, 2025 road vacation. [2025-166]
