The County has been trending in the wrong direction with premium and IMWCA would like to see the County focus on three areas to help minimize claims: utilize light and modified duty return to work programs, incident analysis reviews, and timely reporting of incidents.

The Auditor continued to meet with the Board for approval of voided check and to give an update on the Public Safety Facility construction.

Moved by Swisher seconded by Oswald to set a public hearing on January 6, 2026 at 9:15 a.m. to amend the Jones County Zoning Ordinance Chapter 3 Article VI Non-Conforming Uses to allow parcels split prior to December 2005 and under ten acres to be considered buildable. All aye. Motion carried.

The Engineer met with the Board for approval of a preconstruction agreement, for approval of a revised PPE policy and to get input on the purchase of Bluetooth headsets for Secondary Road employees, and to discuss the differences between union and non-union holidays.

Moved by Zirkelbach seconded by Swisher to approve an updated Secondary Road Department Personal Protective Equipment Policy to include the purchase of Secondary Road insignia clothing. All aye. Motion carried. [2025-200]

The Board gave brief reports on past and future committee meetings.

During the elected official comment period, the Auditor presented 2025 Tax Year valuation information to the Board, the County Attorney commented on providing a more robust holiday schedule for calendar year 2026, and the Treasurer commented on county department clothing purchases and policies.
