## **Jones County Solid Waste Management Commission**

### **February 3, 2026 Meeting Minutes\***

The regular meeting of the Jones County Solid Waste Management Commission was held Tuesday, February 4, 2026 at the Jones County Transfer Station. Commission members present include Russ Benke, Onslow; Jeff Swisher, Jones County; John Schlarmann, Jones County; Dave Goedken, Monticello; David Dircks, Olin, Members were not present from Anamosa, Martelle, Morley, Oxford Junction, and Wyoming. Others present include Andy Jamison, director, and Alicia Presto, ECICOG.

The meeting was called to order at 5:11 PM by Benke.

There were no visitors present to provide public comment at the meeting.

Motion was made by Schlarmann to approve the January 6, 2026 meeting minutes. Motion was seconded by Swisher. The vote was unanimous, motion carried.

Motion was made by Swisher to approve expenditures and the financial report. Motion was seconded by Goedken. The vote was unanimous, motion carried.

Presto provided an update on assistance provided by ECICOG including preparation for the library reading program and training for staff.

The Commission discussed nominations for the chairperson, vice-chairperson, secretary, and treasurer officer positions. Swisher made a motion to elect Benke as chairperson, Schlarmann as vice-chairperson, and cease nominations. The motion was seconded by Goedken. The vote was unanimous, motion carried. Goedken made a motion to designate Andy Jamison as the secretary and treasurer. The motion was seconded by Swisher. The vote was unanimous, motion carried.

The Commission discussed which members of the Commission should be designated as executive committee members. Per by-laws, the chairperson, vice-chairperson, and three additional members of the Commission may serve on the committee. Schlarmann made a motion to designate Swisher, Goedken, and Dircks as members of the executive committee. The motion was seconded by Swisher. The vote was unanimous, motion carried.

The Commission discussed a draft personal protective equipment policy that establishes procedures, requirements, and an annual allotment for staff to purchase necessary personal protective equipment. Motion was made by Goedken to approve the personal protective equipment policy. Motion was seconded by Swisher. The vote was unanimous, motion carried.

The Commission discussed options to increase efficiency at the transfer station including software to record and track waste. No action was taken.

The Commission discussed Saturday hours at the transfer station. A motion was made by Goedken to change Saturday hours to the second and fourth Saturday of the month with the hours of 8 AM to noon starting July 1, 2026. Motion was seconded by Dircks. The vote was unanimous, motion carried.

Motion made by Goedken to adjourn the meeting. Meeting adjourned at 6:16 PM.
