Brief Descripon of Project: Development of a concrete trail around Central Park Lake connecng into the current beach area and fishing access.

AND, Land and Water Conservaon Fund financial assistance is being sought for the acquisition or development of said outdoor recreaonal facilies,

NOW THEREFORE, be it resolved by the Jones County Conservaon Board that the project described above be authorized

AND, be it further resolved that said Jones County Conservaon cerfies to the following:

1. That it will accept the terms and condions set forth in the NPS Grants-in-Aid Manual and which will be a part of the Project Agreement for any grant awarded under the atached proposal.
2. That it is in complete accord with the atached proposal and that it will carry out the development in the manner described in the proposal and any plans and specificaons atached thereto unless prior approval for any change has been received from the Iowa Department of Natural Resources.
3. That it has the ability and intenon to finance its share of the cost of the project and that the project will be operated and maintained at the expense of said Conservaon Department for public outdoor recreaonal use.
4. That no financial assistance has been given or promised under any other federal program or acvity with regard to the proposed project.
5. That it will not discriminate against any person on the basis of race, color, or natural origin in the use of any property or failure acquired or developed pursuant to this proposal, and shall comply with the terms and intent of the Title VI of the Civil Rights Act of 1964, P.L. 88-352 (1964), and of the regulaons promulgated pursuant to such Act by the Secretary of the Interior and contained in 43 CFR 17.
6. That it will maintain adequate financial records on the proposed project to substantate claims for cost-sharing.
