



Immunization Audit Report 2019

Assessments of children attending licensed childcare centers, preschools, or elementary or secondary school are conducted to ensure attendees have received the required immunizations and have an appropriate Certificate of Immunization, Certificate of Immunization Exemption, or Provisional Certificate of Immunization. Immunization audits are completed between October and January for all schools, preschools, and licensed childcare facilities. Immunization requirements are posted on the Iowa Department of Public Health’s [Immunization Program website](#).

- *Provisional Certificate*: Child is not immunized according to requirements, but has a temporary certificate that allows 60 days to update their immunizations.
- *Exemptions*: Medical and Religious Exemptions are the only exemptions available in Iowa.
- *No Certificate*: Child does not have an acceptable certificate or does not have any immunization certificate on file.
