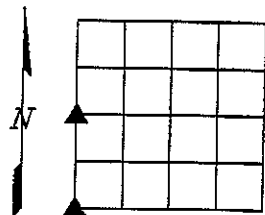
## PLAN - VIEW

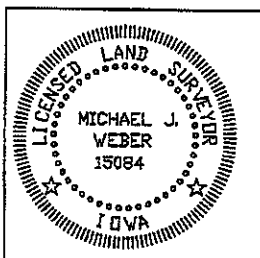
