3. That a scrivener's error has been detected on said certificates and in accordance with the provisions of Chapter 354.24, Code of Iowa, the following correction should be substituted for the erroneous data on said certificates:
  - A. In the box on each certificate labeled "Monument Description and Remarks", the section number is mistakenly stated as 36 when in fact Section 35 is correct as stated elsewhere on each certificate.
4. That the correction stated herein does not affect the locations of the boundaries or the areas depicted on the related plat recorded in Plat Book O - Page 139.
