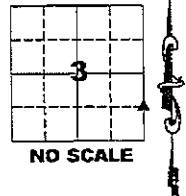

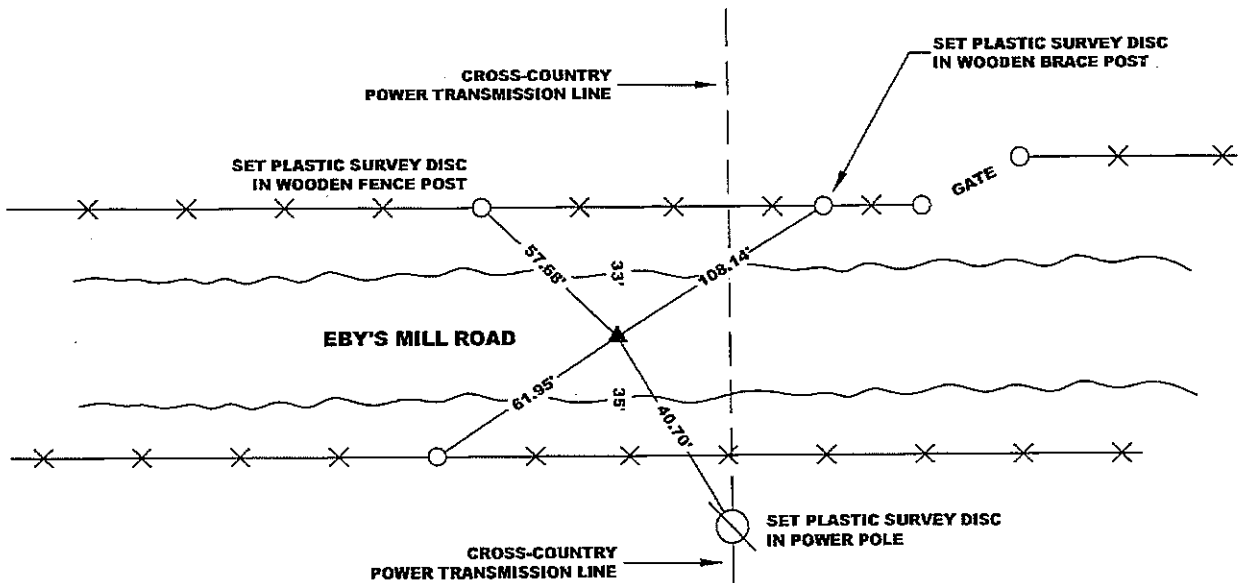

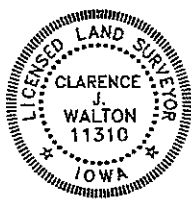

SET ONE 5/8"X24" REBAR AND ONE 5/8"X48" REBAR ON NORTH AND SOUTH SIDES OF STONE RESPECTIVELY FOR DETECTION PURPOSES. SET SMALL MAGNET ON TOP OF STONE ALSO FOR DETECTION PURPOSES. SET 3/8" X24" REBAR W/ ORANGE PLASTIC CAP #11310 DIRECTLY ABOVE STONE AND 4" BELOW PRESENT ROAD SURFACE.
