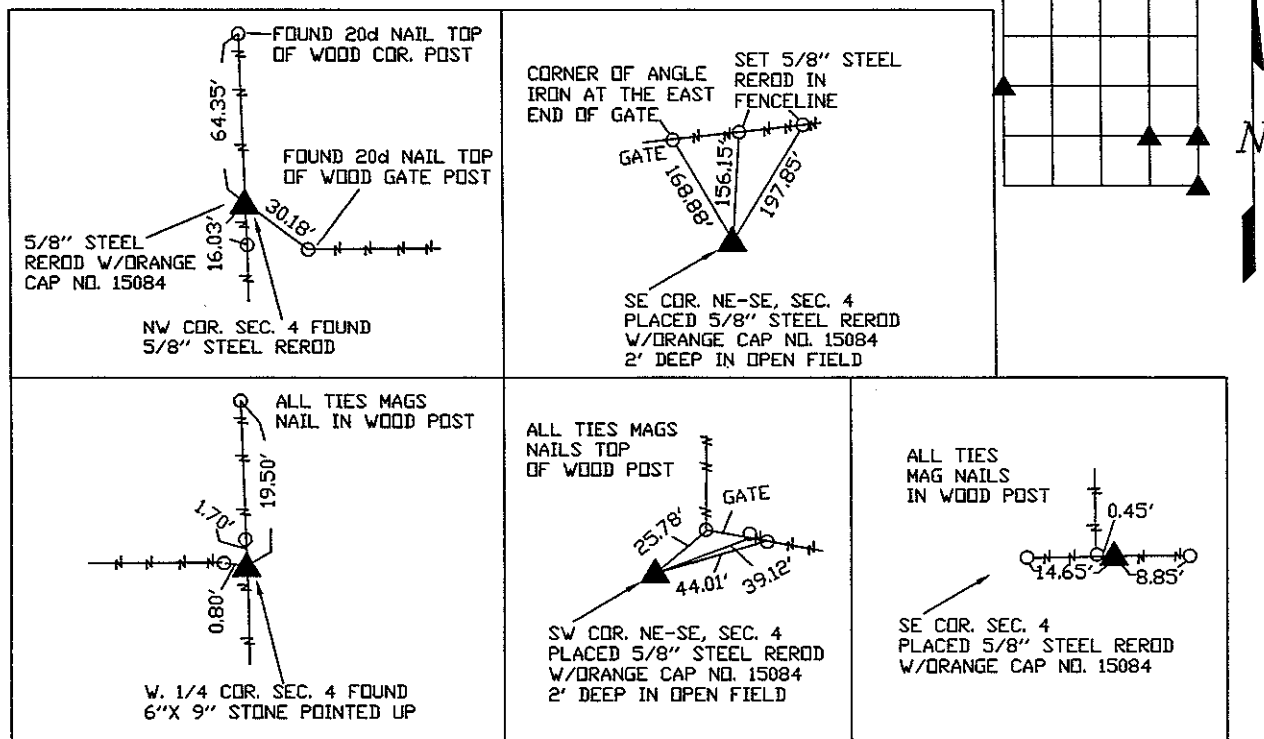

- SE COR., NE-SE, SEC. 4, PLACED 5/8" STEEL REROD W/ORANGE PLASTIC CAP MARKED "WEBER PLS 15084" MIDWAY AND ONLINE BETWEEN THE EAST 1/4 AND THE SE COR., SEC. 4
- SW COR. NE-SE, SEC. 4, PLACED 5/8" STEEL REROD W/ORANGE PLASTIC CAP MARKED "WEBER PLS 15084" ESTABLISHED CORNER BY BREAKING DOWN THE SE 1/4, SEC. 4
